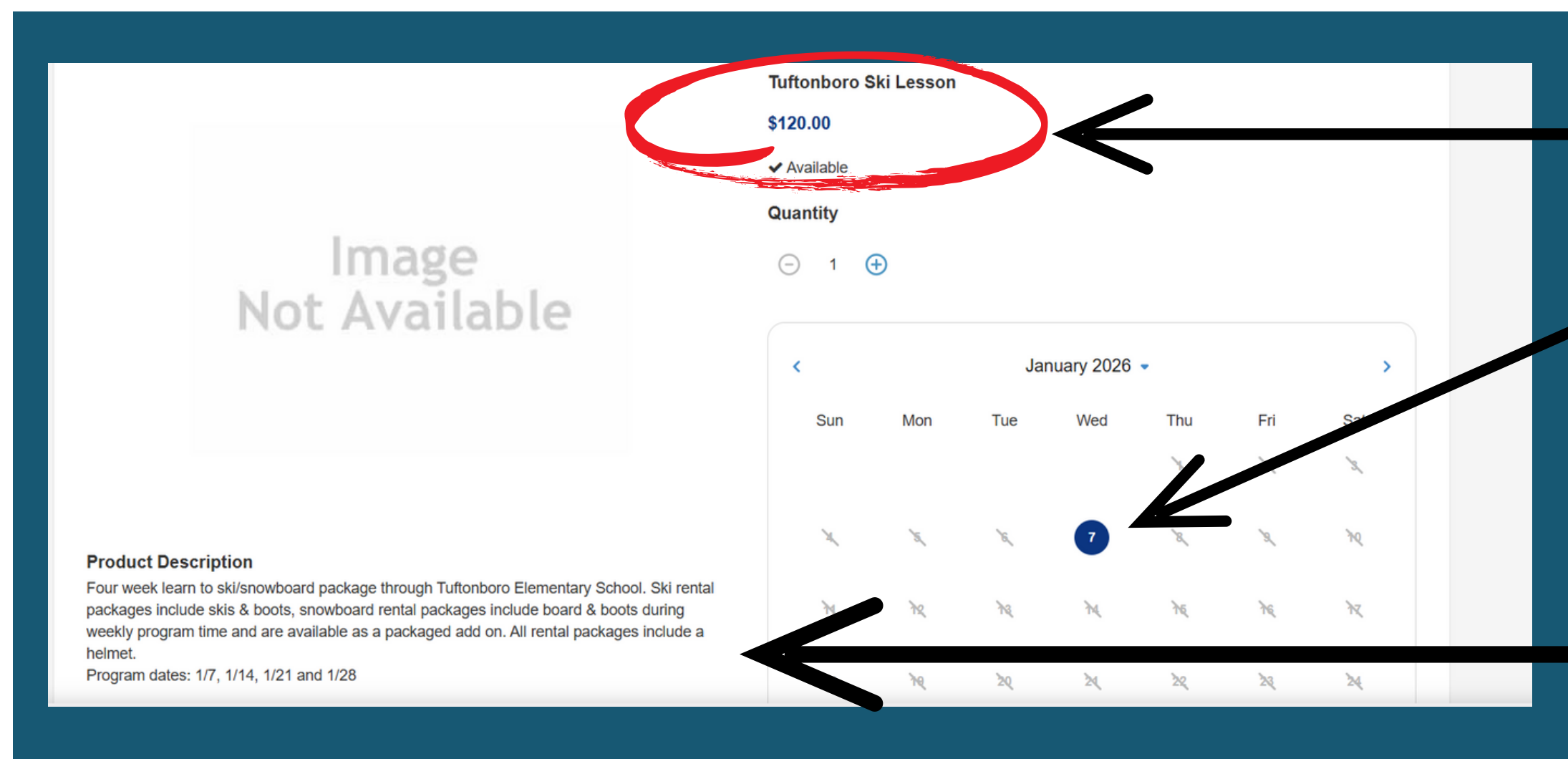


Tutorial for Online Sign-Up Process for School Groups

**The names and prices displayed in this tutorial are merely examples for reference purposes; they are not linked to your school or recreation department.*

- 1. Choose the correct link for either ski or snowboard discipline
- 2. Once you open the link, you should be able to see this screen:

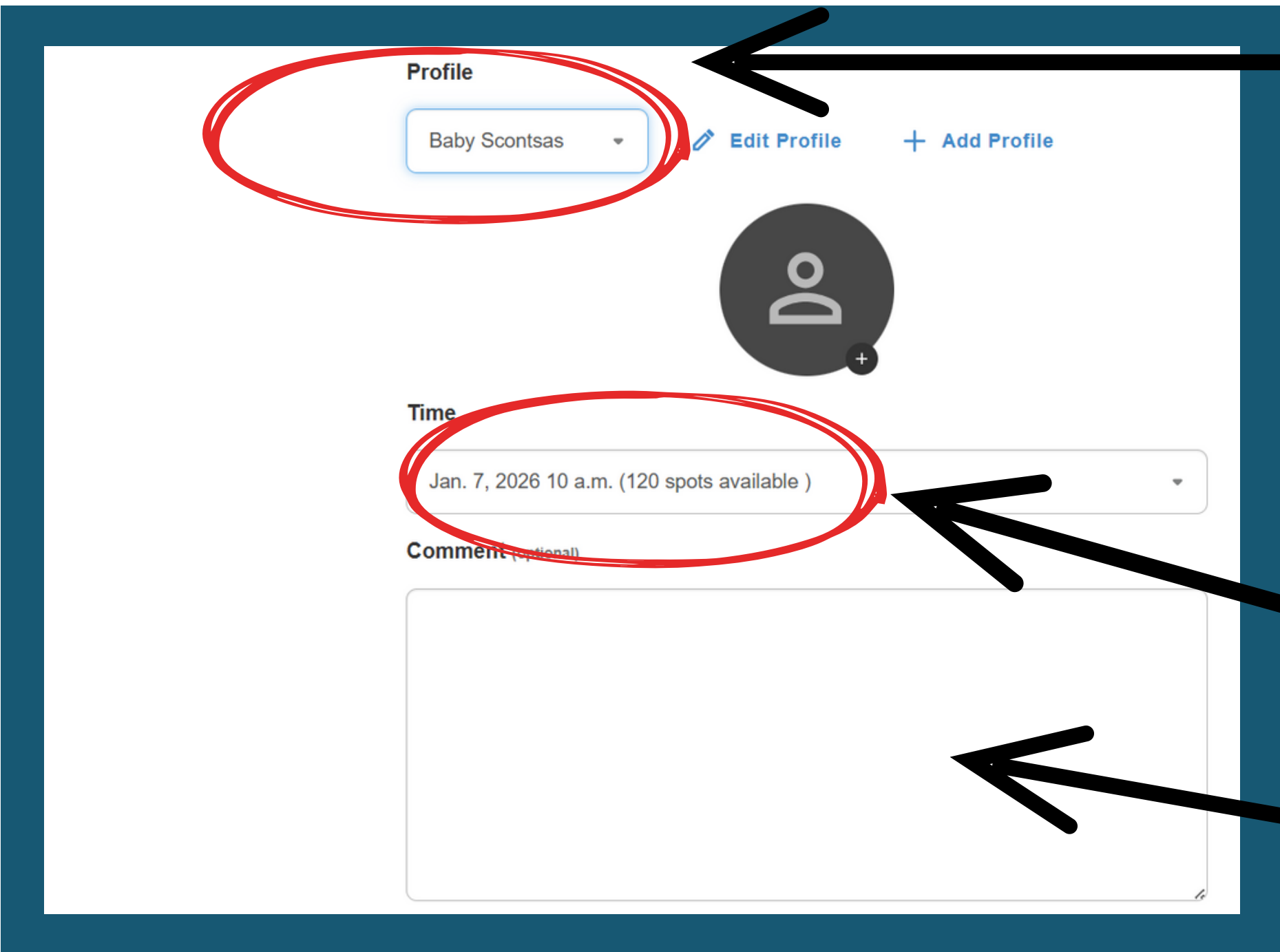


Here, you will find the name of your school or recreation department along with the pricing for the lesson package.

- 3. You will have to create a parent/guardian profile, as well as child profile (we launched a new system, so if you have signed up online last season, this info will not be here).



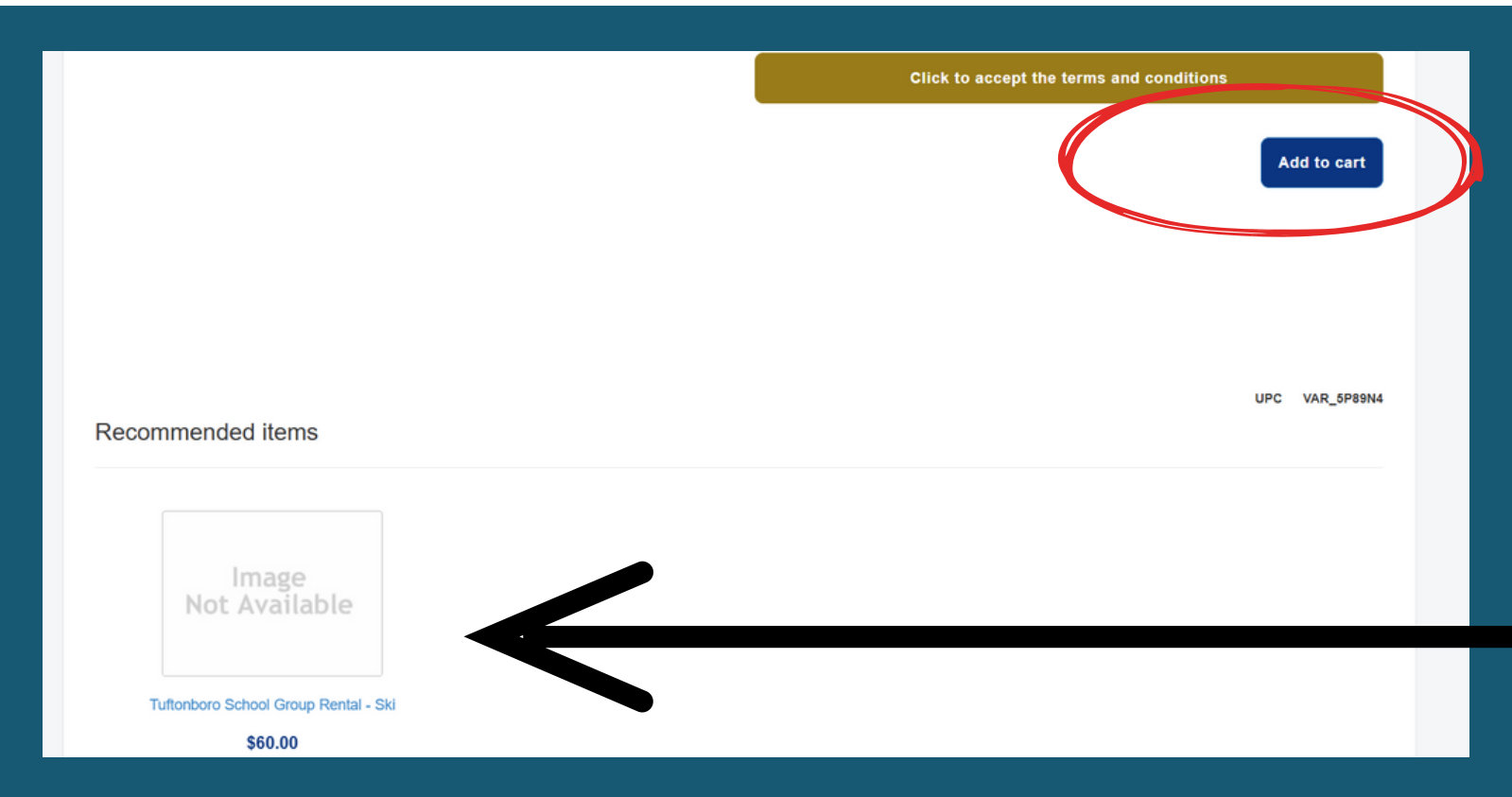

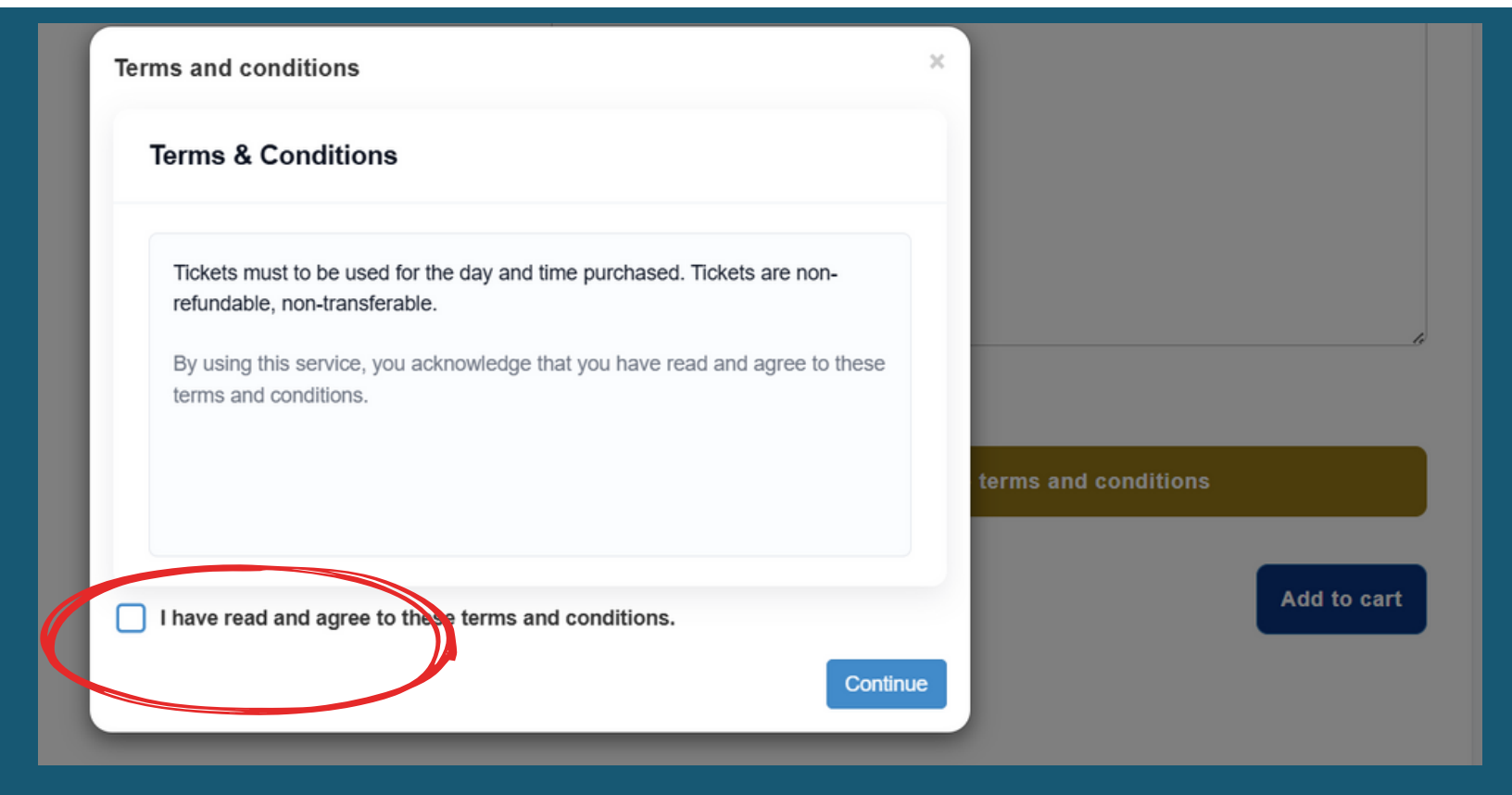
The time shown indicates the beginning of the lesson, not the arrival time.

The notes section is designated for any extra information you would like the Snowsports School to be aware of regarding your child.



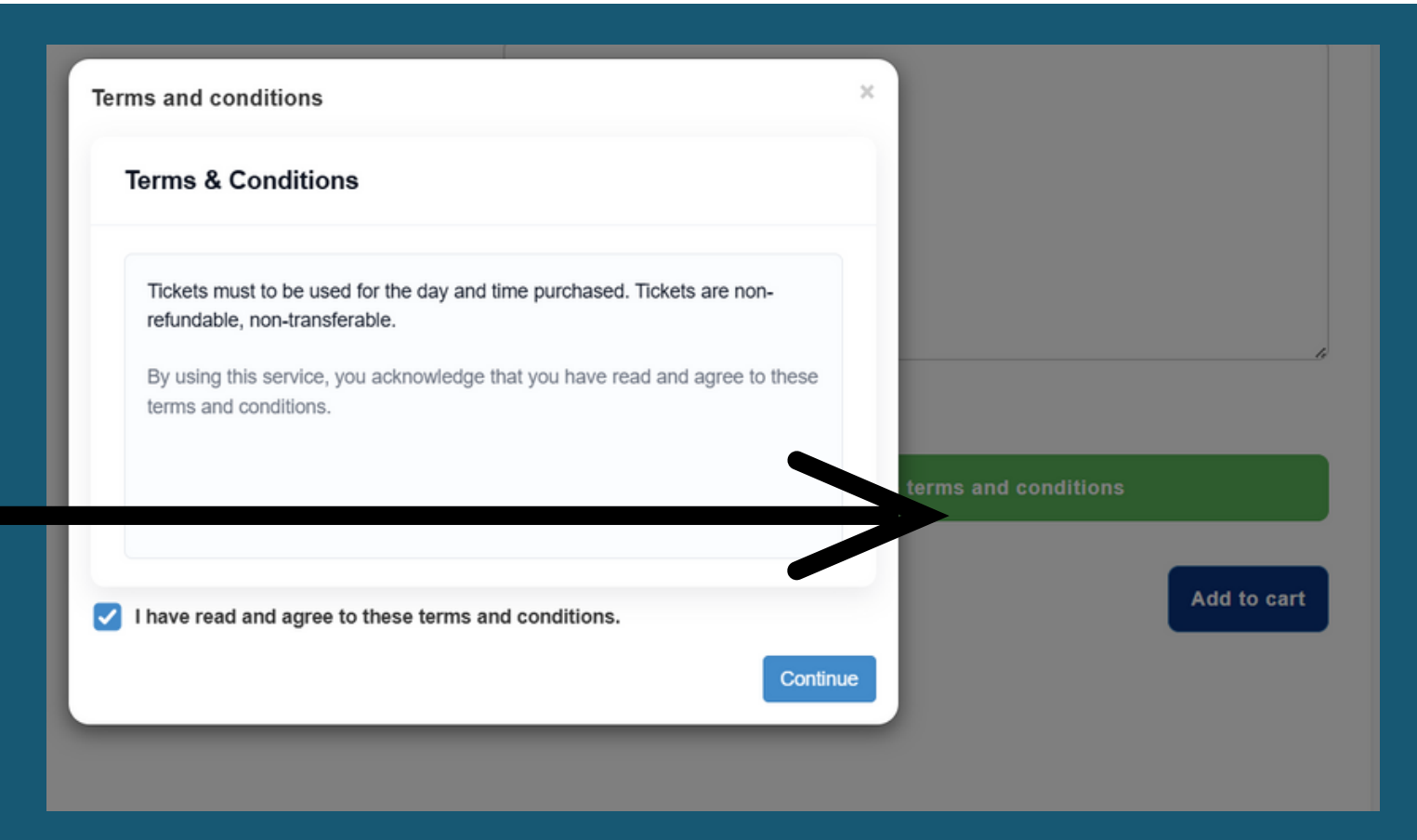
4. Add to cart

At the bottom of the screen, you'll find a recommendation for Rentals. This suggestion will also reappear once you add the Lesson Package to your shopping cart.

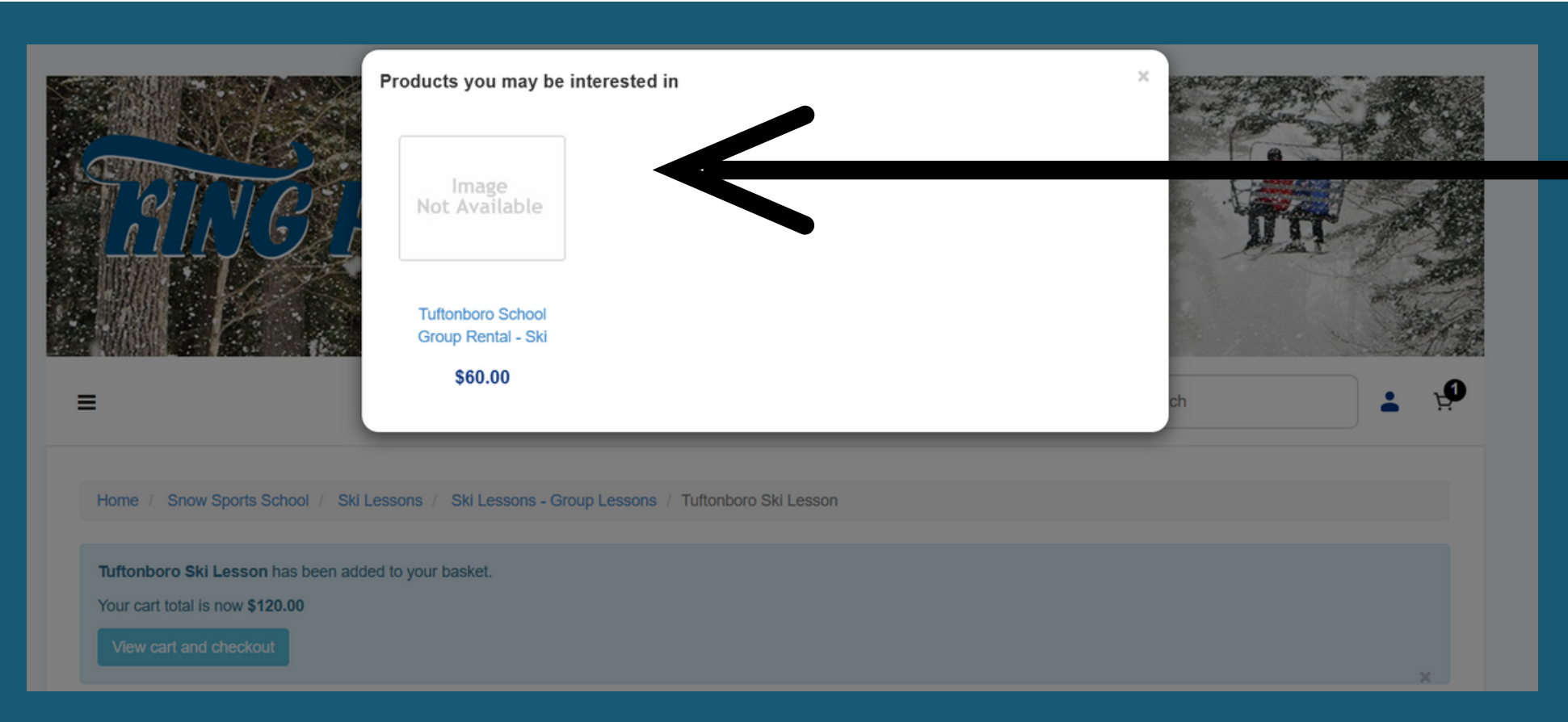


5. Before you can add a product to your cart, you must agree to the terms and conditions.

6. Once you check the box, the Terms and Conditions bar will change to green.

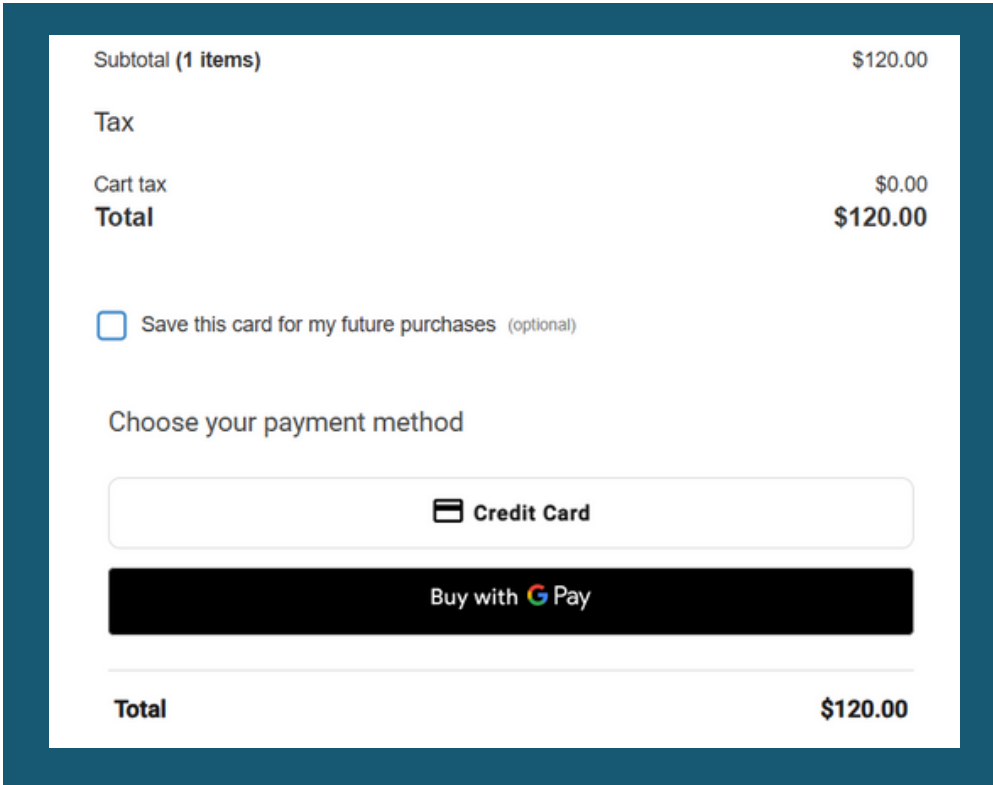


7. Now you can add product to the cart.

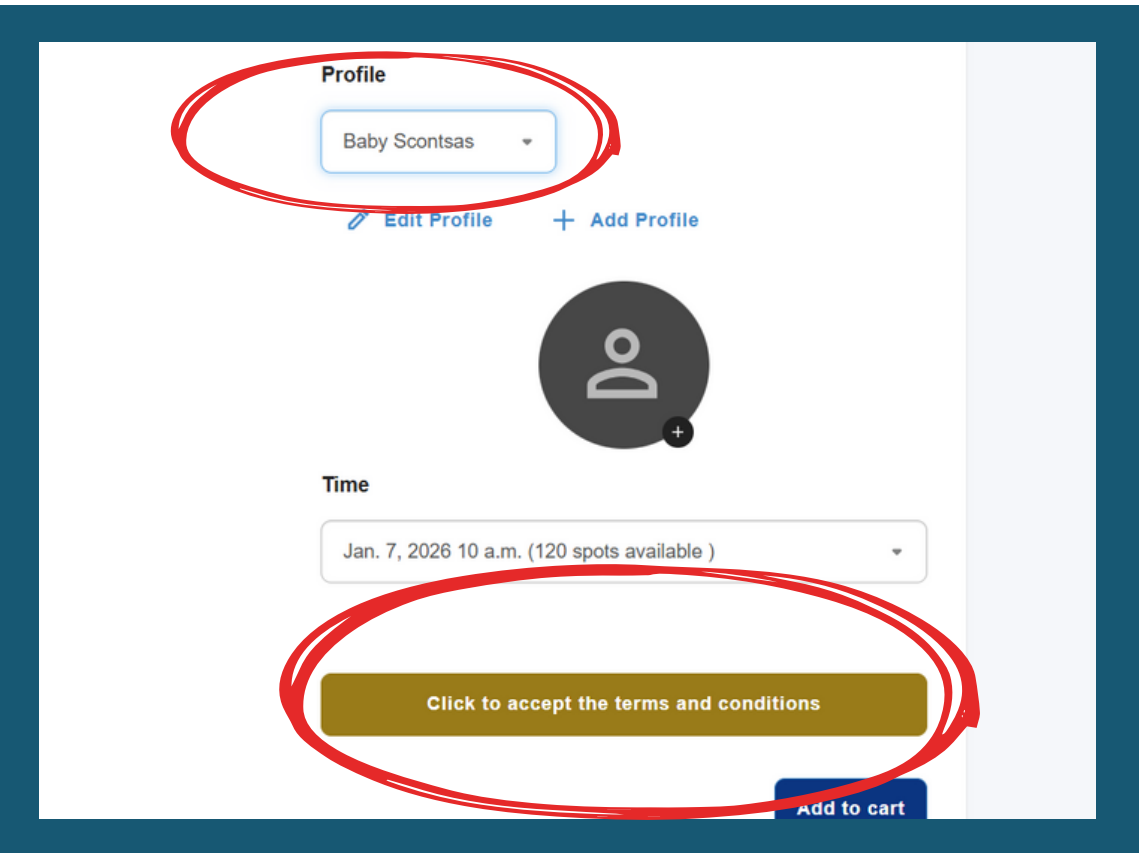
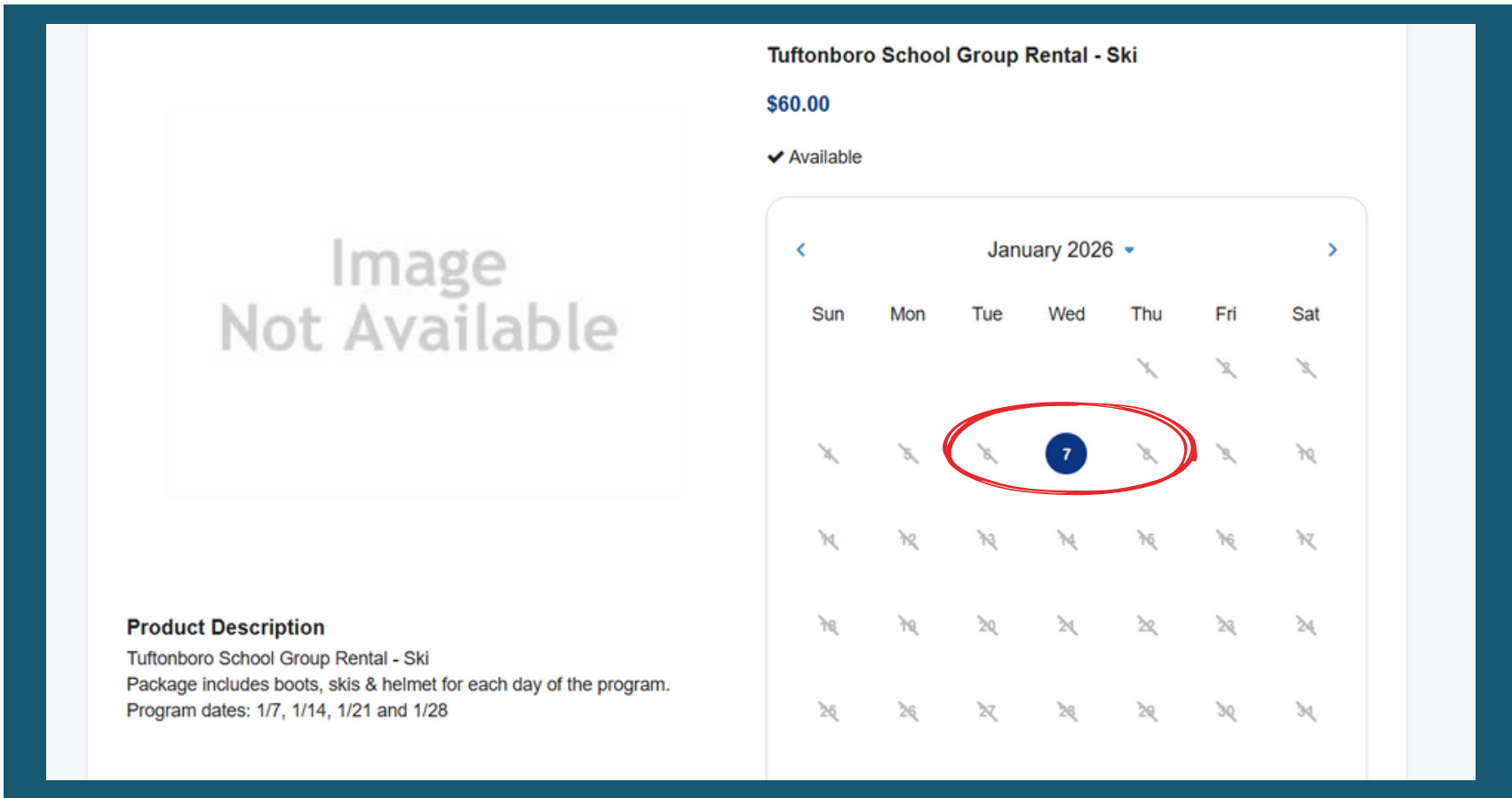


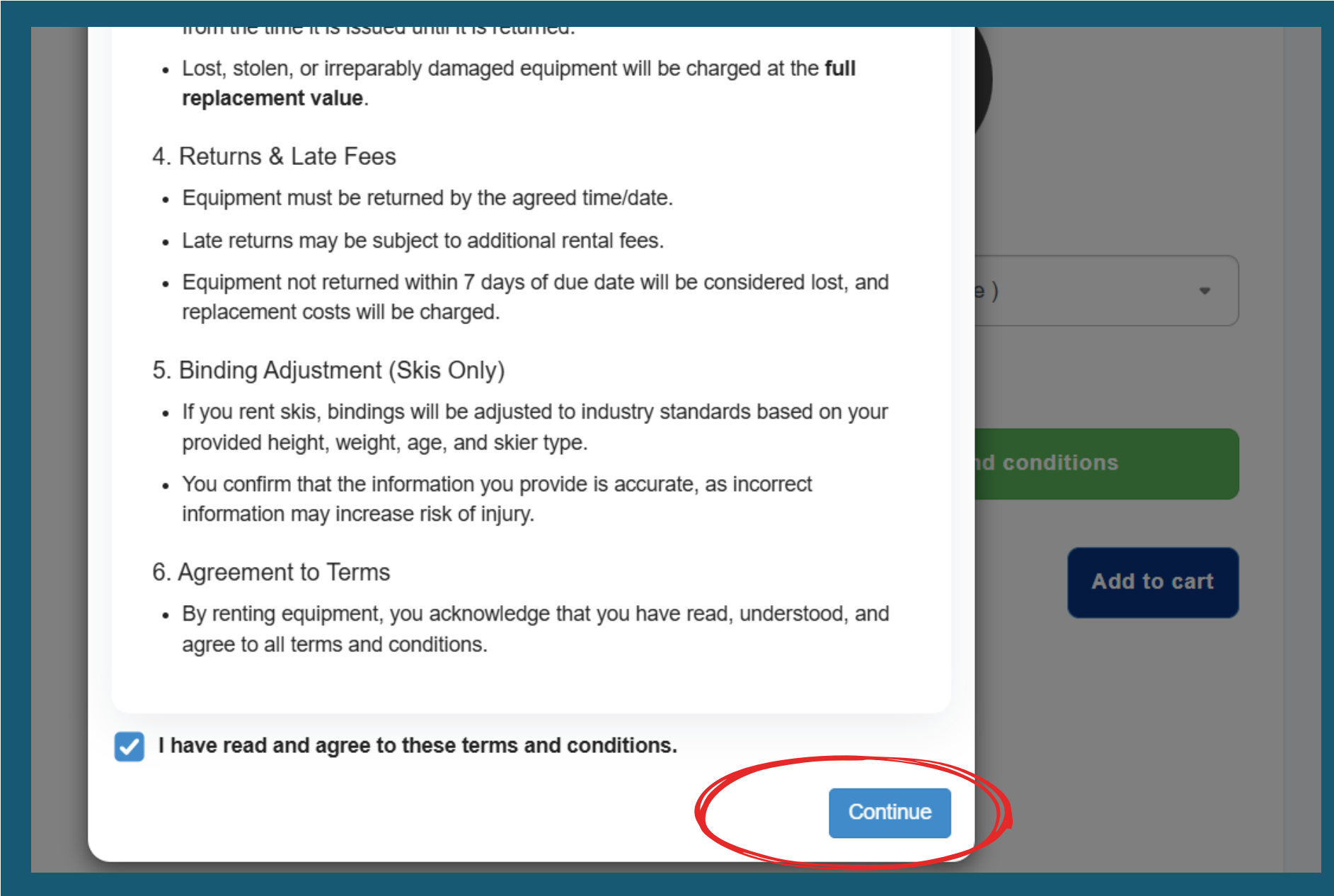
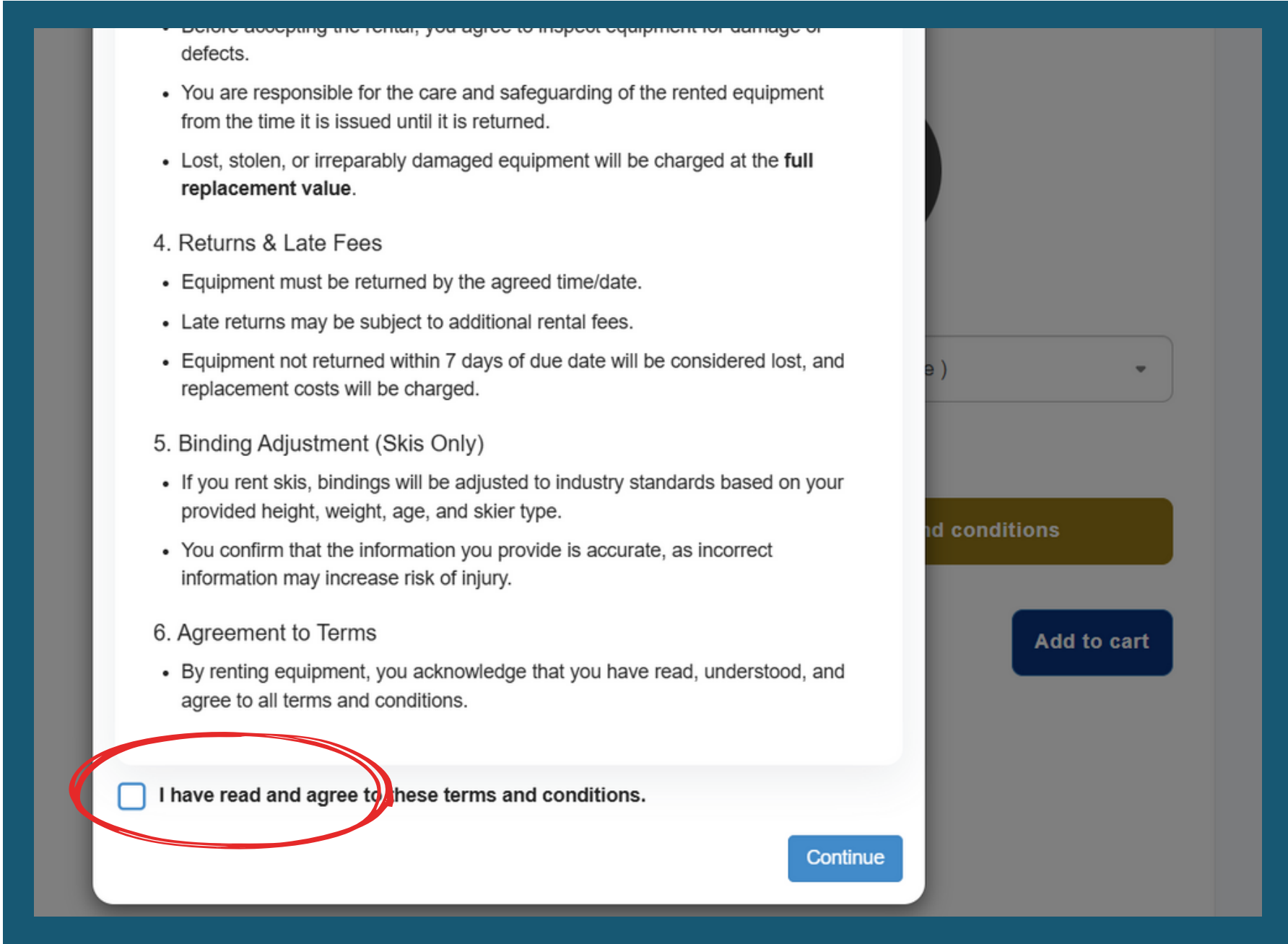
The window displaying the recommended rental products will appear. Simply click on the rental product designated for your school and follow the steps to add the rentals.

If you decide to opt out of Rentals, press on “View Cart and Checkout” and you will be redirected to the payment page, where you simply need to complete your payment.

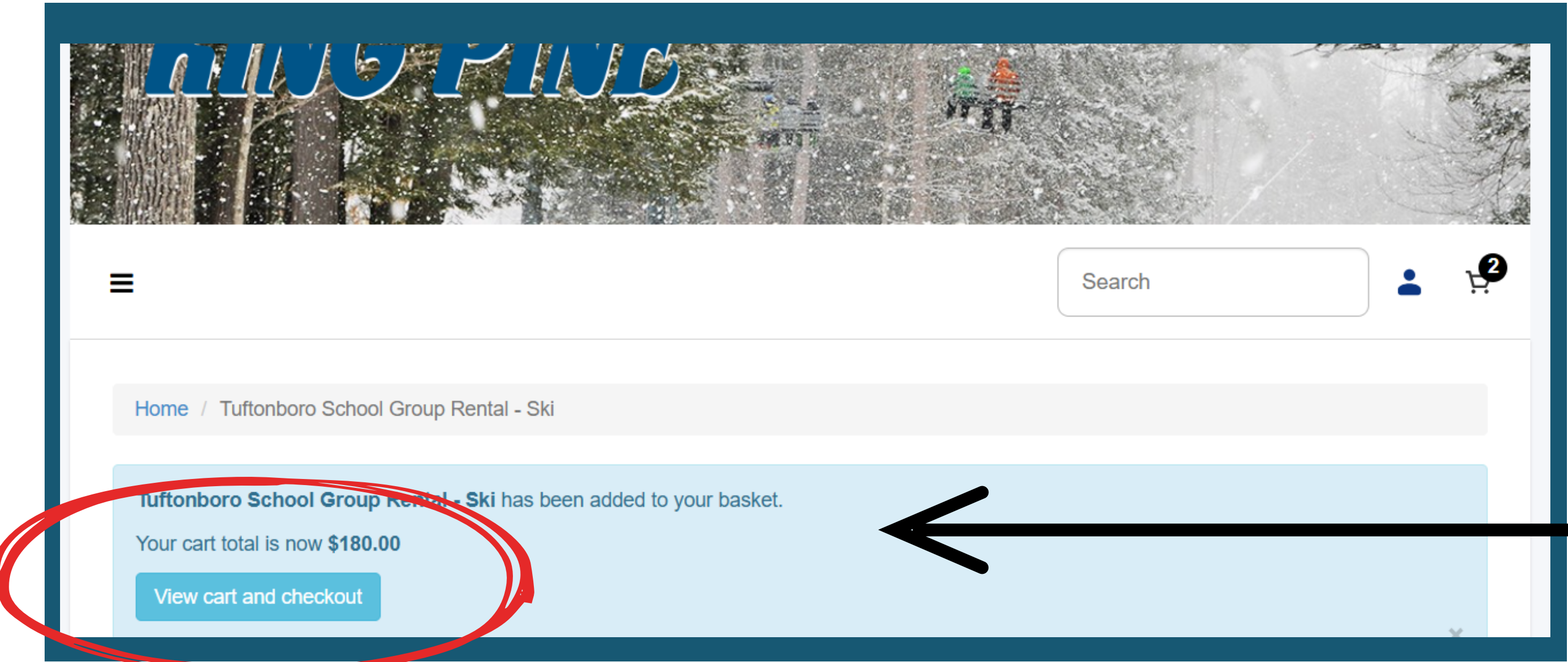


8. Simply Follow the same path for Rentals as you would for the Lesson Package:

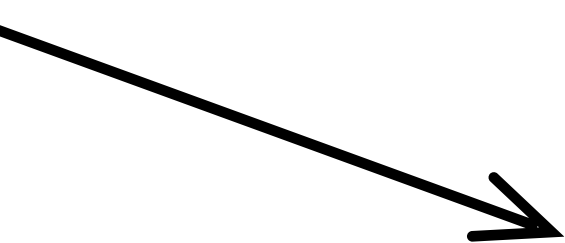

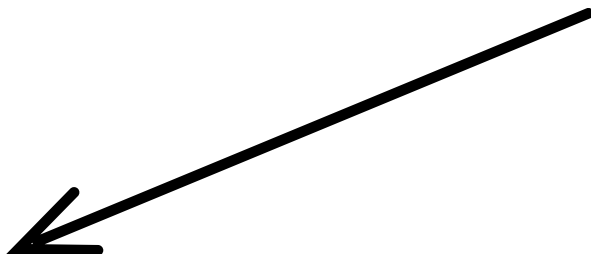
